Rules of Play

1. Eligibility

- Open to employees and volunteers (18 years of age or older), residing in Manitoba, and working or volunteering in the Interlake-Eastern Regional Health Authority.
- Regulations prohibit the following persons and their immediate families residing in the same household from purchasing a ticket: IEHF Foundation staff and board of directors

2. Ticket Purchase & Registration

- Tickets are purchased through bi-weekly payroll deductions for those who opt-in.
- Casual staff, volunteers, or staff whose personnel areas do not match the participating organization, may be eligible to purchase tickets via credit card.
- Participants may select from multiple deduction options (1 ticket for \$5, 3 tickets for \$10, 10 tickets for \$25, 50 tickets for \$50), with each tier corresponding to a set number of tickets.
- Once registered, payroll deductions continue until the participant cancels (see Section 7).
- No refunds will be issued once payroll deductions are processed, and tickets are non-transferable
- Lottery ticket purchases are not tax-deductible, and no tax receipts will be issued.
- This event is administered by Interlake Eastern Health Foundation (IEHF).
- Information is protected and governed by the privacy policies of the IEHF. Any personal information is collected for the purpose of fulfilling this Lottery and to promote future PayDay PayOut 50/50 lotteries. IEHF does not rent, sell, or trade our mailing lists. - IEHF does NOT have access to the personal information for any staff members or volunteers. If you move or change your personal information, you must contact iehf@ierha.ca directly in order to keep your Staff Lottery file up to date. IEHF does not take responsibility for misdirected renewal forms due to unreported changes to personal information.

3. Draw Frequency & Method

- Draws occur bi-weekly in accordance with the schedule described in Appendix A.
- Each draw is conducted using an LGCA-approved electronic raffle system provided by Raffle Box. No specific numbers can be given as numbers are generated randomly.
- Draw to be conducted at IEHF Offices, 233 A Main Street, Selkirk on the dates outlined in Appendix A
- Winners are determined by random selection from all eligible participants in that pay period.
- Chances of winning for each draw depend on the total number of tickets sold (i.e., the total number of participating employees across all Participating Organizations).

4. Prize Structure

- The winner receives 50% of the ticket revenue from that draw.
- The remaining proceeds will be used by IEHF to support health care priorities.

5. Winner Notification & Publication

- The winning participant will be contacted by phone or email.
- Winners' names may be posted on the IEHF PayDay PayOut 50/50 website.
- Prizes will be paid by cheque by the IEHF.

6. Claiming Prizes

- Winners have six (6) months from the draw date to claim their prize.
- Any unclaimed prize after this 6-month period will be retained by IEHF.

7. Cancellation of Participation

- Participants can cancel their payroll deduction at any time by notifying IEHF at iehf@ierha.ca or calling 204 485 5139
- Opt-out requests must be submitted at least 10 business days prior to a draw to take effect. Any requests received after this cutoff will be applied to the following draw cycle.

8. Publicity & Consent

- By participating in this lottery, each entrant agrees that, if they win, the IEHF PayDay PayOut 50/50 may use their name, likeness, and/or photographs in external and internal communications (including websites, social media, or promotional materials), without additional compensation or notice, except where prohibited by law.

9. General Conditions

- This lottery is conducted under the authority of the Liquor, Gaming and Cannabis Authority of Manitoba (LGCA).
- This lottery is licensed and administered by Interlake Eastern Health Foundation (IEHF).
- Any matters not covered by these rules will follow LGCA regulations and IEHF Board of Directors decisions.
